EMA Policy update

An update to the EMA Policy on the publication of clinical data for medicinal products for human use was published on the 22nd of September and is available [here](#).

This document provides guidance on the procedural aspects of the submission of clinical reports, the anonymization of clinical reports, and the identification and redaction of commercially confidential information in clinical reports.
