

EMWA 2019 Nick Thompson Fellowship Award

Established in 2001, The Nick Thompson Fellowship Award recognises service to EMWA above and beyond what would normally be expected of members or those who hold or have held elected offices.

Nick Thompson, for whom this award is named, was a member of EMWA who embodied the collegial spirit, bonhomie, and professional dedication which represent the core persona of the organisation. He died tragically young. EMWA wishes to recognise and preserve those values that were so important to Nick. The Award confers lifetime EMWA membership and registration at association conferences on the elected Fellow. Fellows serve informally, in the capacity of advisors to the organisation, given their length of service, knowledge of the history of EMWA, and their involvement in the profession.

The Fellows will consider all nominations and will advise the EC, via the President, of the results of their deliberations. Please do not inform the candidate that you have nominated them.

Up to two scholarships are available in memory of one of the founding fathers of EMWA, Geoff Hall, who sadly passed away in 2010.

The essay title for 2019 is "How would you go about identifying a predatory iournal?"

The submission deadline for entries is 30 September 2019.

Eligible applicants must be new medical writers: that is, they intend to enter the profession or have been employed for no longer than one year as a professional medical writer, including freelance work. They need not be current members of EMWA.
